## **TERMS AND CONDITIONS FOR PARTICIPATING AGENCIES WITH DONATION MEMBERSHIP IN IKC**

1. We understand that by signing this application we are entering into a contractual agreement between ourselves and In Kind Canada (IKC). IKC facilitates the donation of materials to qualified donees. The ownership of the material we receive shall be transferred from the donor to our organization. We will be responsible for reporting the value of all material to the Canada Revenue Agency on form T3010, the Annual Charity Return as well as reporting any charitable receipts issued by our organization.
2. We understand that the items allocated to our agency will be in good and working condition at the time of delivery and that neither IKC nor the donor provides any warranty. It is our responsibility to obtain maintenance or service agreements for any business machines provided through IKC. We will not approach the donor to provide or donate such services or request further material.
3. Where computer equipment has been provided we understand that all licensed software should have been removed unless licensed copies of the software were donated with the computer.
4. We understand that IKC will not be liable for any loss or damage to any material due to circumstances beyond IKC's control, including but not limited to, the failure of electronic or mechanical equipment, operator errors, governmental restrictions, severe weather or natural disasters.
5. By agreeing to these terms we indemnify IKC and its respective affiliates, and all of their officers; directors; legal representatives; employees; successors; assigns and agents; and hold them harmless from and against any and all claims, proceedings, damages, injuries, liabilities, losses, costs and expenses (including legal expenses), relating to or arising from our agency's use of any donated material.

## **MATERIAL BEING DELIVERED**

1. We understand that wherever possible IKC will attempt to have the donor cover the cost of having the donation delivered to an address designated by the member.
2. When the donor is unable to cover the cost or the donation must be separated into partial shipments to distribute to multiple member agencies, we understand that a condition of receiving the donation will be full payment of the delivery cost to the address designated by the member. IKC will hold no liability for any cost incurred for delivery once the member has agreed to receive and pay for delivery of a donation.

## **ADDITIONAL TERMS AND CONDITIONS FOR IKC PROGRAM MEMBERS**

1. As a Program member we understand that our agency will not be eligible to receive donated goods unless our organization changes status and becomes a qualified donee (registered charity) and reapplies to In Kind Canada for Donation membership. This stipulation is as per Canada Revenue Agency guidelines, which only allows receipted items to be transferred to other qualified donees.
2. We understand that In Kind Canada does not provide any warranty. The Service Provider, depending upon their service, may provide their usual warranty.
3. In Kind Canada assumes no responsibility or liability for claims that may result directly or indirectly from the provision of donated services, including breach of warranty claims.
4. We agree not to request the Service Provider to donate any part of their product beyond that outlined in the specific discount program being offered by that company.
